

QUALIFICATIONS AND CREDENTIALLING REQUIREMENTS

MINIMUM QUALIFICATIONS BY POSITION

The table below outlines the minimum qualifications required for a position with National Patient Transport in accordance with the relevant state regulatory requirements.

Ambulance Transport Attendant (ATA)	Diploma of Paramedical Science plus have at least 400 hours of supervised on road clinical practice in either an Emergency or Non-Emergency setting <u>over a period of not less than 2 years</u> .	✓		✓
	Bachelor of Paramedicine or a Graduate Diploma of Paramedicine conferred by a university. Individuals must also hold current APHRA Registration and provide evidence of their registration on an annual basis		✓	
	Bachelor of Nursing with current APHRA Registration and relevant clinical experience. RN must have <u>current ALS qualification</u> and be proficient in ECG interpretation.	✓	✓	✓
Critical Care Registered Nurse (CCRN)	Graduate Certificate in Critical Care Nursing with current APHRA Registration. CCRNs must have a current ACLS certificate which is less than 12 months old.	✓		

ACCEPTABLE EVIDENCE TO SUPPORT JOB APPLICATION

As a pre-requisite of employment with NPT, the following documentation is required to be completed and uploaded as part of your application. Please ensure that you have electronic copies of the required documentation prior to commencing your application via NPT's Careers page at www.nptgroup.com.au. Failure to supply the required certified documentation may result in a non-compliance of your application.

DOCUMENT REQUIREMENT	ACCEPTABLE EVIDENCE
Drivers Licence	Certified colour copy of your full unrestricted Drivers Licence – <u>both sides</u>
Driver Record	Driver history record issued by the relevant State Roads Authority

DOCUMENT REQUIREMENT	ACCEPTABLE EVIDENCE
Proof of Residency	Certified copy of proof included either copy of Passport, Birth Certificate, Citizenship Certificate or Visa.
Curriculum Vitae	CV detailing current and previous experience
Qualifications & Registrations	Certified copy of any applicable Qualification (Certificate, Diploma or Degree) AND Registration (e.g. AHPRA Registration) associated with the position being applied for. Qualifications must also include a list of all units of competency / subjects completed. CCRN applications must also include copies of Graduate Certificate in Critical Care Nursing and current ACLS Certificate.
National Police Check	Certified copy of a National Police Check which has been obtained within the last 3 months. The National Police Check MUST indicate position type: e.g. Patient Transport Officer, Ambulance Attendant, Registered Nurse or as a minimum Patient Transport etc.
Working with Children's Check	Certified colour copy of a Working with Children's Check (WWC). The WWC MUST be an Employee check rather than a Volunteer Check. If you do not currently have a WWC, please note that they can take up to 1 month to be completed. Note: In WA this is not required on application but will be finalised as part of the recruitment process
Statutory Declaration and Consent Form	Download the Statutory Declaration and Consent Form . Enter all required fields on the form, print and take to authorised witness under the Oaths and Affirmations Act 2018 to witness your declaration and signing.
Pre-Employment Health Questionnaire	Download the Pre-Employment Health Questionnaire and complete all required fields prior to signing.
Pre-Employment Immunisation Screening Form	Download the Pre-Employment Immunisation Screening form and complete all required fields. Evidence of immunisations must also be supplied with the completed form. Only the specified evidence will be accepted. Failure to supply the required evidence will result in your application being assessed as incomplete.
Evidence of Clinical Supervision Hours (Vic ATA positions only)	If applying for a position of an Ambulance Attendant (Vic only) please provide evidence of your 400 hours of on road clinical practice by a Clinical Instructor
